



CALL FOR PARTICIPANTS FOR THE EUROPEAN PROJECT: M2ICOS - MOBILITY TO MOBILITY TO IMPROVE CLINICAL ONCOLOGY SKILLS, COD.2024-1-IT01-KA122-VET-000211936, CUP: G41B24000390006

The present call is published under condition, pending the release of the Call Erasmus+ 2024 and the subsequent signing of the Erasmus+ 2024 financial agreement between the National Agency INAPP/Erasmus and the European School of Oncology. All activities and funding mentioned in this call are therefore subject to change following what may be provided by the rules of the financial agreement Erasmus+ 2024.

Article 1 – Scope of VET Mobility

Key Action 1 aims to strengthen the European dimension of teaching and learning, promoting the values of inclusion and diversity, tolerance and democratic participation, knowledge of Europe's common heritage and diversity and supporting the development of professional networks across Europe. Namely, in the field of Vocational Education and Training contributes to the implementation of the Council Recommendation on Vocational Education and Training and the Osnabrück Declaration, the European Skills Agenda and the creation of the European Education Area.

Article 2 – Project Description and Activities

M2ICOS is a Short Vocational Educational Training Mobility Project funded under Erasmus + Programme (2024-1-IT01-KA122-VET-000211936) led by the European School of Oncology. The M2ICOS project aims to expand mobility opportunities for practicing and continuing education oncologists. Article 3– Beneficiaries, Type and Duration of Mobility

Under M2ICOS's Project, in the period from 30-1-2025 until 31-12-2025, ESO may activate:

1. N.12 Short Mobility lasting up to 89 days
2. N.12 Long Mobility lasting up to 180 days

The beneficiaries of the Project M2ICOS are:

1. Medical doctors specialized in oncology (pediatrics, surgery, gynecology, hematology, palliative care, immunotherapy, gastro-enterology, urology, neurology, pathology, psycho-oncology, radiotherapy)
2. From 25 to 40 years old
3. In the condition to start from Italy – Italy is the only admissible leaving and returning place from/by to reach the hosting institution
4. Learners will be selected according to the selection procedure highlighted in article

Article 6 – Selection of Participants

The selection procedure will based on the following criteria:

-CV (PAST EXPERIENCES), THE TOTAL POINTS RANGE FROM 0 TO 39:

- 4 most important past experiences: 0 to 4 points
- Research experience in a laboratory: No = 0, Yes = 5 points
- **EXPERIENCE IN TRANSLATIONAL RESEARCH: NO = 0, YES = 5 POINTS**
- **EXPERIENCE IN CLINICAL RESEARCH: NO = 0, YES = 5 POINTS**
- **PUBLISHED ARTICLES IN SCIENTIFIC JOURNALS (LAST 5): 0 TO 10 POINTS**
- **PREVIOUS FELLOWSHIP ABROAD (EXCLUDING ESO): YES = 0, NO = 10 POINTS**
- Master Degree in Medicine - It does not assign points on its own (it is included in the '4 most important past experiences' section above)
- Medical Specialization in Oncology – 5 to 10 (if the person completed their specialization more than 5 years ago, they are not eligible).
- Support letter by Head of Department - 0 to 10 points
- Knowledge of English
- Pre-intermediate/beginner = Not eligible

The call will open on **17th December 2024** and will close on **16th January 2025**.

The participant will be selected on merit ranking considering all the provisions outlined in article 6.
ESO will proceed with selection within 30th January 2025.

Article 7 – Grants Disbursement procedure

Each selected beneficiary involved in M2ICOS will receive support as follows:

- a) the individual support as outlined in Article 5 will be disbursed in equal monthly installments. The first installment will be disbursed within 10 days prior to the scheduled departure date, while subsequent installments will only be disbursed if, within 30 days of arrival at the hosting institution, the participant provides proof of payment for accommodation costs (the participant should fill Annex 2). If this documentation is not provided, ESO will not disburse any further installments after the first until the required proof of accommodation costs is submitted. No supporting documentation will be required for subsistence expenses.
- b) A reimbursement of travel costs, as outlined in Article 5, upon completion of the TRAVEL COST REFUND FORM (Annex 3) at the end of mobility period. Participants should transmit to ESO the refund form within 10 days by the end of mobility period, ESO will proceed with the refund within 10 days (di calendario).

All transfers will be made via bank transfer to the bank account registered in the name of the beneficiary for the mobility program.
